

**Spokane County  
Transportation Tax  
Effective April 1, 2019**

**Effective April 1, 2019**, sales and use tax within Spokane County Public Transportation Benefit Area (PTBA) will increase one-tenth of one percent (.001). The tax will be used for transportation purposes.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within Spokane County PTBA. Persons or businesses within these areas will be subject to the new tax rate for reporting use tax on items purchased for their personal or business use if sales tax has not been paid.

The new rates of sales tax are:
