Local sales/use tax changes

(Effective April 1, 2018)

Clallam County

Sales and use tax within all of Clallam County will increase one-tenth of one percent (.001). The tax will be used for juvenile detention facilities and jails.

Columbia County

Sales and use tax within all of Columbia County will increase one-tenth of one percent (.001). The tax will be used for emergency communication systems and facilities.

City of Connell

Sales and use tax within the City of Connell will increase two-tenths of one percent (.002). The tax will be used for transportation services.

City of Ellensburg

Sales and use tax within the City of Ellensburg will increase one-tenth of one percent (.001). The tax will be used for housing and related services.

City of Long Beach

Sales and use tax within the City of Long Beach will increase two-tenths of one percent (.002). The tax will be used for transportation services.

City of Moses Lake

Sales and use tax within the City of Moses Lake will increase two-tenths of one percent (.002). The tax will be used for transportation services.

City of Mukilteo

Sales and use tax within the City of Mukilteo will increase one-tenth of one percent (.001). The tax will be used for transportation services.

Okanogan County

Sales and use tax within all of Okanogan County will increase one-tenth of one percent (.001). The tax will be used for juvenile detention facilities and jails.

Motor vehicle sales and use tax

Motor vehicle dealers and motor vehicle leasing companies must collect the additional sales tax of three-tenths of one percent (.3%) of the selling price. This applies to every retail sale or lease of a motor vehicle in Washington. "Motor vehicle" means every vehicle that is self-propelled as defined in RCW 46.04.320. However, this does not include farm tractors, farm vehicles, off-road vehicles, non-highway vehicles, and snowmobiles. Changes for marketplace facilitators, remote sellers and referrers

Beginning January 1, 2018, marketplace facilitators and remote sellers with sales of \$10,000 or more to Washington consumers must either:

- Collect sales/use tax on sales to Washington consumers
- Follow the specific notice and reporting requirements explained on the Department's website at dor.wa.gov/marketplacefairness

What is a marketplace facilitator?

Generally, a marketplace facilitator contracts with sellers to facilitate sales of a seller's product through a physical or electronic marketplace.

What is a remote seller?

Generally, a remote seller is a seller who does not have a physical presence in Washington and makes retail sales into Washington.

What is a referrer?

- Contracts or otherwise agrees with a seller to list or advertise one or more items for sale in any medium, including a web site or catalog
- Receives payment from the seller for the listing or advertisement
- Transfers a purchaser to a seller or an affiliated person to complete the sale
- Does not collect receipts from the purchasers for the transaction
- Does not provide the marketplace seller's shipping terms
- Does not advertise whether a marketplace seller charges sales tax

The definition of "referrer" does not include a person that:

- Prints or publishes a newspaper (RCW 82.04.214)
- Provides internet advertising services

There are substantial penalty provisions associated with the failure to comply with the legislation EHB 2163, Chapter 28, Laws of 2017, Parts II and III.
