

**City of Enumclaw  
Transportation Benefit District  
Effective April 1, 2016**

*Effective April 1, 2016*, the City of Enumclaw will establish a Transportation Benefit District (TBD). Sales and use tax within the City of Enumclaw will increase one-tenth of one percent (.001). The tax will be used for transportation services.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within the City of Enumclaw (1711). Persons or businesses within the City of Enumclaw will be subject to the new tax rate for reporting use tax on items purchased for their personal or business use if sales tax has not been paid.

The new rates of sales tax are:
