



Kittitas County Public Safety Tax
Car Dealers and Leasing Companies
Effective April 1, 2008

Effective April 1, 2008, local sales and use tax within all of Kittitas County will increase three-tenths of one percent (.003). The tax will be used for the purpose of providing funds for criminal justice and public safety purposes.

Persons or businesses within Kittitas County will be subject to the new rate of use tax on items purchased for their personal or business use if sales tax has not been paid.

The retail sale or use of motor vehicles, and the lease of motor vehicles for up to the first thirty-six months of the lease, are exempt from the public safety tax imposed. After the first thirty-six months of motor vehicle leases the public safety tax would apply and the original city/county code would be used.

How to Report:

Please use these rates and location codes for all retail sales or use tax except the special reporting of motor vehicle leasing sales.

Special Reporting Instructions for Sales or Leases of Motor Vehicles:

Businesses that report sales or leases of motor vehicles (for up to the first thirty-six months of the lease) will need to report using the following tax rate:

Below is an example of how to report local retail sales tax on your excise tax return assuming sales of motor vehicles total \$50,000 and repairs total \$10,000 in Kittitas County.

New sales tax applies i.e. service and parts.

Represents only motor vehicle sales.

Note: The three-tenths of one percent (.003) Motor Vehicle Sales/Lease Tax that was implemented July 1, 2003 still applies to the sale, lease, or rental of motor vehicles.
