

520 Bridge Project Application for Sales and Use Tax Deferral 47.01 RCW

General Instructions - Please Read Carefully

Who May Apply?

Any *person involved in the construction of the state route number 520 bridge replacement and HOV project may apply for the deferral of state and local sales and use taxes on the:

- Site preparation of,
- construction of,
- acquisition of any related machinery and equipment that will become a part of this project, and
- rental equipment for use in this project.
- * For purposes of this deferral, a "person" has the same meaning as in RCW 82.04.030 and also includes the Department of Transportation.

Filing:

Application shall be made to the Department of Revenue on this form. No taxes are allowed to be deferred until the application has been approved and the certificate has been issued by the department. The department has 60 days to approve applications.

Applications and any other information received by the Department of Revenue under this deferral program are <u>not</u> confidential and are subject to disclosure.

Project Operationally Complete:

The 520 Bridge Project will be considered operationally complete when the replacement bridge is constructed and opened to traffic.

Repayment of Deferred Taxes:

The first payment is due on December 31 of the fifth calendar year after the certified completion date with subsequent annual payments due on December 31 of the following nine years. Each payment shall equal 10 percent of the deferred tax. The Department of Revenue may authorize an accelerated repayment schedule upon request of a person granted a deferral under 47.56 RCW.

Insolvency or other failure of any private entity granted a deferral for this project does not extinguish the debt of deferred taxes.
