

#### Instructions for Determining your Annual Small Business Credit (SBC)

If you need assistance determining your percentage of taxable income, follow steps 1 through 3 in the worksheet below.

If you answer "yes" to question 1 below, use Table 1.

• Was **50% or more** of your taxable income reported under Service and Other Activities, Service and Other Activities (\$1 million or greater in prior year), Gambling Contests of Chance, For Profit Hospitals, Scientific R&D, and/or Real Estate Commissions?

If you answer "yes" to question 2 below, use Table 2.

• Was **less than 50%** of your taxable income reported under Service and Other Activities, Service and Other Activities (\$1 million or greater in prior year), Gambling Contests of Chance, For Profit Hospitals, Scientific R&D, and/or Real Estate Commissions?

Once you determine which credit table to use, follow steps 4 through 7 below to calculate your net B&O tax due.
